- C. Discussion and possible Action related to request from Neil Watson regarding grove at 1855 River Bend Drive, Redlands
  - a. Commissioner Day motioned to direct City staff to bring the proposal from Neil Watson's grove to Council for consideration with a temporary agreement for the City to manage & maintain the grove that ensures all City costs are accounted for.
  - b. Commissioner Shaw suggested the use leverage of City to for small private growers to share in the costs of maintaining their groves (i.e., spraying)
  - c. Commissioner Day and others asked if he would be willing to sell grove to City at appraised value with a guarantee that is stays as agricultural/open space?
