





"I move to recommend that the City Council accept the recommended name of "<u>Joe Gonzalez Community Center</u>" for the Redlands Community Center located at 111 W Lugonia Ave."

"I move to recommend that the City Council accept the recommended name of "<u>Eddie and Gloria Flores Senior</u> <u>Center</u>" for the Redlands Community Senior Center located at 111 W Lugonia Ave."

"I move to recommend that the City Council accept the recommended name of "<u>Mary Reyes Sanchez Dining Room</u>" for the Dining Room at the Redlands Community Senior Center located at 111 W Lugonia Ave."

"I move to recommend that the City Council accept the recommended name of "<u>Martinez Park</u>" for the park currently known as Community Park, located at the corner of Church St. and San Bernardino Ave."

DISCUSSION:

The following name recommendations were submitted for consideration by the Parks and Recreation Advisory Commission pursuant to Resolution 7771.

1. Joe Gonzalez Community Center

- **a.** Mr. Gonzales, past commissioner on the Parks and Recreation Commission, was a dedicated advocate for recreation services and parks. He worked diligently and never gave up hope to one day see park and recreation services for all youth in the City of Redlands. He dedicated his life to equality and equity!
- **b.** Joe is a past parks and recreation commissioner and led the effort for building the Redlands Community Center. He was dedicated to helping young children of Redlands and a strong advocate for free or low cost sports fees for children who were unable to paying fees.
- **c.** Joe Raigoza Gonzales was born November 2, 1929 and passed away November 7, 2018 in Redlands. He was second generation Redlands native. He was raised in North Side Redlands. Went to Lincoln Elementary, Redlands Junior High and Redlands High School. He was employed at Mittens manufacturing plastic lettering. He was employed at Norton Air Fore Base until he retired he retired in 1988. He was married to Irene Gloria Sevilla in 1949 and had three daughters. Joe was interested in helping the Latino youth being productive adults. He became a member of the Menudo Group Group, a community activism group intent

on improving facilities for the children of North Side Redlands. He lead the effort for the building the Community Center. He had good Police relations with the North Side, his Commission Service on the Parks and Recreation Committee, membership with Menudo Group, North Side Impact Committee, North Redlands Visioning Committee, he was also running the snack bar at the at the ball fields, a strong advocate for free or low cost sports fees to the children who could not afford it, he was also involved in giving out bicycles to children who could not afford them. Joe was dedicated individual in helping the less fortunate children of Redlands, He loved the City of Redlands where he was born.

2. Eddie and Gloria Flores

3. Mary Reyes Sanchez Dining Room

- a. Mary Reyes Sanchez demonstrated commendable commitment to the City of Redlands Senior center for over 25 years, making her a perfect candidate for this very prestigious award. Mary volunteered at the Joslyn Senior Center and Redlands Community Senior center assisting with the senior bingo program, serving coffee handling the collection of monies and assisting with the Senior Nutrition program. Despite the many activities that Mary was involved, she still found time to volunteer and participate in senior events. She stepped in to help with serving the disabled, setting up and decorating for special events and selling raffle tickets. Mary enjoyed line dancing and traveling with other seniors. Her dedication to this community was a tremendous asset to the success of the Joslyn Senior Center and Redlands Community Senior Center programs. Her hard work and dedication truly makes Mary Reyes Sanchez a perfect honoree for the distinguished 2023 Redlands Hometown hero award.

4. Martinez Park

- **a.** In honor of the first two Latino City Council members in Redlands:
 - i. Norman N. Martinez (1925-1998)
 - Lifelong resident of Redlands
 - Grew up in the citrus industry thanks to his father who managed groves for various growers
 - Veteran of WWII serving on US Navy PT boats in the South Pacific, 1943-1946
 - Worked as a salesman for the Jim Glaze Lincoln/Mercury car dealership for 36 years
 - First Latin American to serve on the Redlands City Council, serving from 1958 to 1970
 - Served as Redlands's Vice Mayor (Mayor Pro Tem)
 - Very active in the community, including serving as President and Co-Founder of the Redlands Boys Club, President of the Kiwanis Club, President of Redlands Pony League Baseball, and on the boards of the House of Neighborly Service, Red Cross and Community Chest
 - Charter member, state vice-commander and commander of American Legion Post 650 (since 1949), and district commander for the group
 - Officer for 40 & 8 Club and Veterans of Foreign Wars

ii. Oddie J. Martinez (1928-1995)

- Lifelong resident of Redlands
- Grew up in the citrus industry thanks to his father who managed groves for various growers and worked in the groves and packing houses himself while still in school
- Veteran of U.S. Navy during and after WWII (1945-1949), where he was stationed on Iwo
 Jima in the Aviation and Intelligence Service
- First Commander of the American Legion Post 650 in Redlands and was very involved in veterans' issues in the region
- Graduate of University of Redlands, earning a master's degree in administration, and did additional graduate work at Claremont Graduate School and University of Oregon
- Second Latin American to serve on the Redlands City Council, serving from 1978 to 1985
- Served as Redlands's Mayor from 1978 to 1980, becoming the city's first Latin American mayor and the first person to serve in that position from the north side
- Longtime educator who taught at McKinley Elementary School and Cope Junior High School, and was principal of McKinley, Mariposa, and Cram elementary schools over 30 years
- RUSD foreign language coordinator for Cope Junior High and Redlands High School, 1961-1963, and Director of Title I programs and Inter-group Relations Coordinator for the district
- Visiting lecturer at University of Redlands, the University of California, Riverside, California State University, San Bernardino, and San Bernardino Valley College
- Served on the boards of the House of Neighborly Service, Community Chest, YMCA Redlands Chamber of Commerce, United Wat, Redlands Community Hospital, Redlands Community Music Association, and Red Cross
